- Deposit is refundable up to 60 days prior to departure
- Cancellations after 60 days prior to departure will result in the loss of your deposit (\$50.00).
- Tickets are non-refundable once issued – 30 days Prior to departure. Changes will be subject to a \$150.00 change fee plus any fare difference. Must cancel prior to departure date and travel for new ticket must start within one year of date original ticket was issued. Additional restrictions may apply.
- One name change per ticket is allowed up to 48 hour prior to departure for a \$50.00 fee.

Maximum Size and Weight: Ski/board boot bag up to 50 lbs. and 62 inches; One pair of skis/snowboard up to 115 inches.
